

GENERAL AGREEMENT

Between

UNIVERSIDAD CATÓLICA ANDRÉS BELLO (UCAB), a non-profit higher education institution authorized by the Venezuelan State through Decree Nº 42 published in Official Gazette No. 24.269 on October 19, 1953, located at Av. Teherán, Urbanización Montalbán, La Vega, Caracas, Venezuela, RIF Nº J-00012255-5, represented by its president, **FRANCISCO JOSE VIRTUOSO ARRIETA** s.j., CI No. V-5.542.096, RIF V - 055420960, duly authorized to that effect

Hereinafter referred to as « UCAB »,

and

Montpellier Business School Non-Profit Association, a higher education and research institution recognized by the French state, with registered offices at 2300, avenue des Moulins, 34185 Montpellier Cedex 4, France, N° SIRET 790 261 242 00016, APE 8542Z, represented by the current Managing Director thereof, Dr Didier Jourdan, duly authorized to that effect,

Hereinafter referred to as « MBS »,

Collectively referred to as "the Parties".

ARTICLE 1 : OBJECT

This General Agreement is not an academic cooperation contract involving student exchange or any exchange of teacher-researchers. The university will limit itself to mentioning its authorization to recruit students to submit them to the MBS International Admission Exam and if successful, to their integration into the MBS programs where once admitted they will be fully MBS students with all the duties and rights attached to it.

The present General Agreement sets the admission possibilities of UCAB students who don't have French nationality to three different programmes of MBS.

ARTICLE 2 : GENERAL TERMS AND CONDITIONS

It has been agreed to encourage and facilitate UCAB students' applications and access to MBS programmes thanks to:

- An application fee waiver (originally 90€) for all UCAB students' applications to MBS programmes
- A commission of 1000 Euros per UCAB student integrated at MBS that could be affected as a reduction directed to UCAB students' tuition fees at MBS.
